HEAD LICE POLICY

RATIONALE


Head lice (pediculosis) are tiny insects that live on the human scalp where they feed and breed. They do not carry or transmit disease. They are a common cause of head itch and scratching which may lead to infection and swollen lymph glands; therefore, they need to be controlled. Anyone can catch head lice. People get head lice from direct head-to-head contact with another person who has head lice. This can happen when people play or work closely together. Head lice cannot fly, hop or jump.

AIMS

This Policy aims to provide a safe and healthy environment for the college community, to minimize anxiety by acknowledging that most schools will have children with head lice at any given time, to respond to reports of head lice quickly and effectively, to ensure that parents and guardians are well informed about head lice prevention and treatment, and to reduce the spread of head lice.

IMPLEMENTATION

- whilst parents have the main responsibility for the detection and treatment of head lice, our school community will work in a cooperative and collaborative manner to assist all families to manage head lice effectively;
- Rosebud Primary School will distribute up to date, accurate, consistent information on the detection, treatment and control of head lice to parents and staff in the prep orientation pack information will appear in newsletters throughout the year and as required;
- as part of enrolment, parents will be asked to sign a consent form allowing their children to have their hair inspected by staff. The consent form will cover the duration of enrolment at Rosebud Primary School. The consent form outlines the responsibilities of the parent and the college in relation to head lice management. Only children whose parents have signed the consent form will be inspected, however, all students may be visually checked;
- if staff suspect that a student has head lice, the student will be sent to first aid where their hair will be checked and if live lice are found a staff member will contact the parent/carer or emergency contact;
- students identified with head lice will be excluded from attending Rosebud Primary School until appropriate treatment has commenced, in accordance with the Health (Infectious Diseases) Regulations 2001;
- hair that is longer than shoulder length must be tied back at all times
- when RPS is notified of a student with head lice, a letter to parents of students in the same class and the adjoining class will be sent home

- RPS will exercise sensitivity towards students and families with head lice and maintain student confidentiality;
- RPS will encourage students to learn about head lice so as to help remove any stigma or ‘bullying’ associated with the issue; and
- RPS will continue to seek opportunities to increase our collective knowledge, understanding of and response to managing head lice.

Parent Responsibilities

- Regularly (at least once a week) inspect your child’s hair to look for lice or lice eggs and regularly inspect all household members. If head lice are present, use safe treatment practices (refer to, Treating and Controlling Head Lice, Department of Health, Victoria);
- ensuring your child does not attend RPS with untreated head lice (in accordance with Public Health and Wellbeing Regulation 2009);
- using safe treatment practices which do not place your child’s health at risk;
- notifying RPS if your child is affected and that treatment has started;
- washing your child’s school hat, pillow case, etc. to prevent re-infection;
- being aware that one treatment is not sufficient;
- notifying parents of your child’s friends or family members so they have the opportunity to detect and treat their children if necessary;
- being aware that the responsibility to exclude a child from the school rests with the Principal Team;
- being aware that immediate exclusion applies to those children who have live head lice, in accordance with the Health Infectious Diseases) Regulations 2001;

School Responsibilities

- Distributing up to date and accurate information on the detection, treatment and control of head lice to parents and staff;
- RPS head lice policy to reinforce an accurate, consistent approach to the management of head lice infections, which is approved by the School Council;
- upon enrolment of a child, obtaining written parental consent to conduct head lice inspections, to cover the duration of their enrolment at RPS;
- staff will discreetly check a child’s hair if the presence of head lice is suspected (this may take place in the First Aid Room or back of classroom, etc);
- encouraging parents to continue to regularly (preferably once per week) check their child for head lice and providing practical advice to those parents experiencing difficulty with control measures;

- encouraging children to learn about head lice so as to help remove any stigma or 'bullying' associated with the issue;
- being aware that there is no requirement in the Health (Infectious Diseases) Regulations 2001 for a child treated for head lice to obtain a clearance certificate to be issued by a health practitioner or a municipal council, on return to school; and
- where appropriate, and at the Principal Team's discretion, provide an alert notice to the school community, when an outbreak of head lice has been detected in the school.
